#### **TUITION & FEES**

- Tuition Per Credit Hour: \$181.81 Per Credit Hour.
- Application Fee (Non-Refundable): \$30
- Technology Fee (Per Year): \$250
- Library Free (Per Year): \$250
- Graduation Fee (One-time): \$250 A Regular student would pay \$6,000 for the program.
